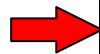

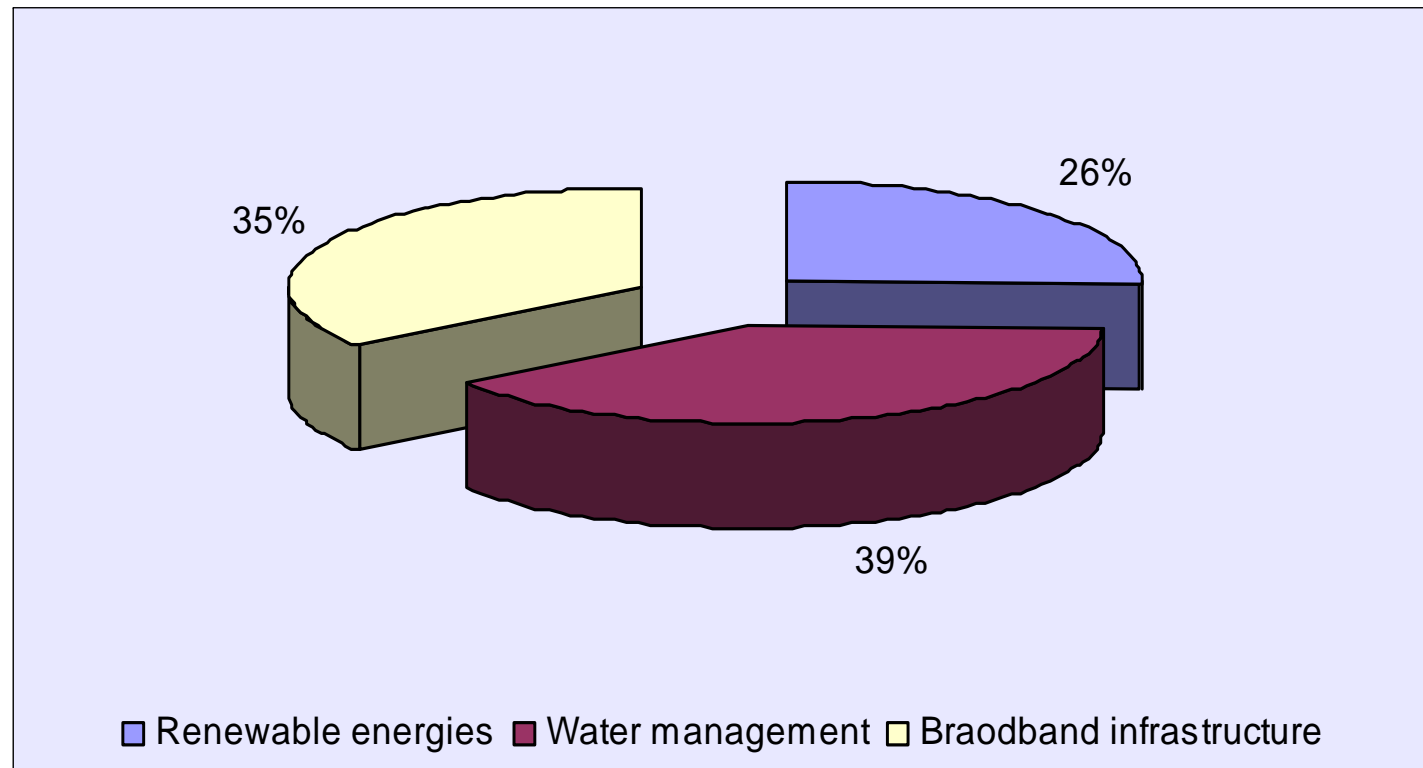

### **Overview: Indicative budget\* by types of measures EAFRD contribution**

#### **Axis 1 €12,851,000**

- **20% on measure 121 (for renewable energies)**
- **20% on measure 123 (for renewable energies)**
- **60% on measure 125 (for water management)**

#### **Axis 3 €6,994,000**

- **all on measure 321 (for broadband in rural areas)**
