This meeting on **"Understanding and implement the results of the evaluations: a roadmap**" concludes the cycle of events on the theme **"The effective use of evaluation results"**.

Understanding the results of evaluation is a fundamental precondition to select the recommendations to follow-up and identify the actions improving the policy and planning. Conducting participatory evaluations facilitates the evaluators to give clarity to the analysis carried out and make administrations aware of the issues on which they were founded.

The meeting aims at analysing the different uses of the evaluations (conceptual, instrumental, influential, process use), identifying possible routes for sharing evaluations, facilitating a better understanding of the findings and the choice of the recommendations to follow-up, in view of improving the policies and the implementation of the programmes.

At the roundtable the speakers will be invited to present their experiences and discuss on the following questions: places and conditions to discuss and share evaluation findings and recommendations; choosing the most useful and practicable recommendations; possible roadmaps to follow-up the results of the evaluations and people to be involved.
