Green New Deal and agricultural entrepreneurship: farmers for land stewardship

The Green New Deal draws a renewed role for farmers within the new Common Agricultural Policy and related strategies and instruments. Its green architecture, although to be discussed at Member State Level in terms of activated measures, conditionalities and priorities, boosts the so-called reinforced conditionalities, transforming the previous greening measures from the I pillar into unavoidable conditions for payments. Furthermore, eco-schemes ease and potentially reinforce farmers' commitment to climate and environmental measures.

At the same time, the new EU Biodiversity Strategy stresses the role of sustainable farming for protecting species and restoring habitats. It mirrors into the Farm to fork Strategy focus on the sustainability of food system, aiming at recognizing and rewarding farmers already committed to sustainability, while stimulating the others to engage in the transition.

In recent years, several farmers' associations, Member States and organizations claimed for the recognition of farmers as land stewards, promoting agreements and collaborating tools.

Basing on the outcomes of LIFE Greenchange project in Italy, the seminar aims to discuss the opportunities for promoting land stewardship in the renewed European framework. At the same time, it aims to reflect on the further conditions needed at different territorial levels to root ongoing experiences and practices while boosting wider farmers' commitment to the stewardship, with a particular view to Mediterranean engagement.
