Main principles



Main principles (1): data on interventions

- Outputs paid shall correspond to the proportion of the expenditure effectively paid in the agricultural financial year concerned;
- Outputs generated by the interventions (in view of accounting under relevant RI) are reported in full from the first payment;

Main principles (2): data on interventions

 For result indicators, the value of the output generated by an intervention shall be reported in full from the first payment (including when it is linked to more result indicators ≠ double counting)

 Farms and beneficiaries are not sistematically reported (i.e. they count only if they are relevant for RIs)

Main principles (5): data on interventions

 Afforested land: two definitions of land (agricultural area and other areas), follow the same principle as in the RI fiches → report under M010 forestry area

Main principles (6): data on beneficiaries

- Data on farmers only (not on other types of beneficiaries e.g. foresters or businesses)
- Data collection point: at the moment of the first claim for IACS interventions (only once per ag. FY)
- Data on beneficiary is regardless of the interventions claimed
- Farm localisation: main activity of the farm (IACS can be used) and whether the farm is in ANC (B07), Nitrate (B08), River Basin (B09) and N2000 (B10)



Examples of interventions

Examples of interventions disclaimer at the beginning that the purpose of these examples is to show how the reporting for monitoring and evaluation would work in practice.

Exact attribution of RI to be considered in light of the detailed description of the interventions.



Ex 1: Description of the situation: Young-farmer (setting-up 4 years ago)

- Farm of 10 ha (in a MS without entitlements)
- Young farmer with support for setting up <u>last instalment 30%</u> (20 000 EUR/operation)
- Complementary income support for young farmers (CIS-YF): 30 EUR/ha
- Basic Income support for sustainability (BISS): 100 EUR/ha
- Complementary Redistributive Income support for sustainability (CRISS): 40 EUR/ha on the first 20 ha.
- Eco-schemes:
 - a. Crop rotation with leguminous crops 75 EUR/ha on 2 ha
 - b. Buffer strips with management practices and without pesticide 250 EUR/ha on 1 ha

Ex 2: Description of the situation: Organic farmer in ANC

- Organic farm: 100 ha (with 80 ha entitlements) + 80 suckler cows
- AEMC conversion to organic: 1 000 EUR/ha (on 100 ha)
- Payment for natural or other area-specific constraints (ANC): 100 ha, for simplification, only one category applies in the example: 40 EUR/ha
- Basic Income support for sustainability (BISS): 100 EUR/ha
- Complementary Redistributive Income Support for Sustainability (CRISS): 40 EUR/ha on the first 20 ha.
- Investment on afforestation (on ag. land): 3 000 EUR/ha (on 2 ha) paid in full in FY
- Coupled income support: 80 suckler cows (conversion 0.8 LU per 1 head),
 100 EUR/head

Cooperation operation involving 150 farmers in the wine sector

TRAININGS

- Training on environmental practices (involving 1 000 of participants)
- Payments: 2 installments: 1st one in FY N (40%), 2nd one FY N+1 (60%).

- Farm of 40 ha (in a MS without entitlements)
- Basic Income support for sustainability (BISS): 100 EUR/ha
- Complementary Redistributive Income support for sustainability (CRISS): 40 EUR/ha on the first 20 ha.
- Eco-scheme: unit amount of 70 EUR/ha on 40 ha
 - a. 2 commitments for Biodiversity on 20 ha
 - b. 3 commitments for Soil on 30ha (20 + 10)
 - c. 1 commitment for Water quality on 5 ha

FARMER G

- Investment in a biomass facility with Energy Capacity per Year: 0.625 MW.
- Payments: 2 installments of 50%: 1st in FY N and 2nd (and final payment) in FN N+1.

PUBLIC INVESTMENT

- Same as Farmer F
- Payments: One single payment in FY N.
