

# THE TERRITORIAL APPROACH IN AGRICULTURAL AND RURAL POLICIES. AN INTERNATIONAL REVIEW

The territorial approach to rural policies is receiving a growing consensus in many countries. Recently, the European Commissioner for Agriculture and Rural Development, Dacian Ciolo, announced that one of the most important future challenges for the EU agricultural policy will be strengthening a territorial approach (*European Conference on Post-2013 CAP, Bruxelles, 19-20 July, 2010*).

Promoted by European Community policies, the approach achieved more interest in many other countries. The OECD in particular highlighted how much these experiences were recurrent, even in different areas, till the point to consider developing a “new rural paradigm”.

On their side, networks as RIMISP (Latin American Center for Rural Development) enabled these experiences to emerge in many different Latin American countries through designing and implementing territorial research projects.

Indeed, it becomes increasingly evident that territorial approach can ensure a better integration among the sector policies at local level in different countries.

The Conference aims to:

- a) provide the opportunity for an international consultation and interchange of experiences;
- b) call for attention of the main institutional actors to the benefits of territorial approach;
- c) establish and strengthen future collaborations among institutional actors, international organizations and rural development networks.

Representatives of international organizations as FAO, IFAD, OECD, UNDP, UNESCO, UN Women, The Ford Foundation and prestigious research institutes have been invited from different geographical areas to show evidence of territorial approach effectiveness in socially and economically distinct rural contexts.
