Key principles

Narrower and meaningful scope → LAG level instead of Regional or National level

- To keep having current information on LEADER, which will be necessary also in the future
- To limit data requests as much as possible but relevant to monitor and evaluate LEADER – Twice in the period for EU evaluations (2026 and 2030) [...]
- [...] while having relevant information on potential determinants (size, composition, etc.) and type of outputs (expenditure, number of projects/operations, etc.) of LEADER in a meaningful way (by objective, by type of promotor, etc.)
