


Topic

- Ad-hoc workshops organized and facilitated by Helpdesk
- Validation of outputs by Sounding Board and ExCo












- What should the ex post guidance achieve?
 - To draw on the lessons from the MTE (e.g. review evaluation questions, provide specific support for the assessment of programme impacts etc.)
 - To provide pratical support to Managing Authorities to prepare for the ex post.
 - To provide examples to evaluators on advanced methodologies in evaluation (→ counterfactuals, netting out etc.)



What are the forseen working steps?

- 1. Screening good practices (preparatory activity)
- 2. Kicking-off the TWG
- 3. **Involving** evaluation stakeholders from the Member States
- 4. Drafting of guidelines
- 5. Dissemination of guidelines
