





## Overview

The Global Evaluation Initiative is convening the 3<sup>rd</sup> annual gLOCAL Evaluation Week to help promote local and global Monitoring and Evaluation knowledge exchange and capacity development.

gLOCAL Evaluation Week is an M&E knowledge sharing initiative that aims to support the exchange of M&E knowledge and experiences as a means to promote evaluation capacity development, support evidence-based decision making, and strengthen development outcomes at local and global levels.

gLOCAL was launched in 2019 and in the short time since, partners from around the world have hosted M&E focused events across five continents in multiple languages. This year, it will take place between May 31 and June 4, 2021.

During this week events, the Italian NRN is holding two events and taking part in a FAO, IFAD and WFP initiative to produce, use, and promote evaluation practice and methods among the global stakeholders and practitioners involved in rural development policies. These initiatives might represent an important opportunity to strengthen local and global M&E capacity and improve outcomes, through an interactive discussion at worldwide level.



## Description

The increasing availability of big data is opening up new frontiers in evaluation, especially in relation to the digitalisation of agriculture. Evaluators are increasingly using ready-to-use, unstructured and micro data which support assessing the effects of programmes and policies at farm, farming systems and environment levels. This could lead more robust and meaningful evaluations.

Besides, it implies the renewal of approaches, methods and tools of data management and information systems and also the redefinition of the collaborative relationships of evaluators, with data scientists and social scientists, that ensure the high quality, efficient and adequate processing of data for evaluation purposes.

## Objectives

The panel session has the overall objective to reflect on innovative experiences in relation to data collection, management and processing for evaluations in the context of the agricultural policies. This will imply:

- ✓ Sharing experiences in the field of data collection, management and processing for evaluations, including use of digital tools in agriculture;
- ✓ Learning from innovative data collection and processing methods ready-to-use for evaluations in the context of agricultural policies;
- ✓ Expert discussion on approaches, methods and relational implications relating to the use of digital data in agriculture.



## Description



During several programming cycles of the European Agricultural Policy, starting from 1988, important changes have taken place in relation to the vision and role of evaluation in policy making, reforming and implementation.

Since the programming period 2007-2013, evaluation during the programme has been introduced with the purpose of fostering on-going learning and accompanying improvements of programme design and implementation. A process evaluation that became less periodic and more systematic to be better tailored upon the needs for evaluative knowledge of policy makers and programme stakeholders. This evolution of evaluation purpose and practices certainly has brought to a major awareness and widespread culture of evaluation among programme managers.

## Objectives



The objective of the session panel is to share experiences and views on approaches put in use to ensure an effective capitalization and sedimentation of evaluative knowledge over time for the purpose of improving programme design and implementation of public policy, by focusing on:

- ✓ Uses and utilization of programme evaluation;
- ✓ Practices and methods for knowledge management of evaluation results.


