# 1. Introduction to EU FADN

- Farm Accountancy Data Network (FADN)
- What?
  - EU-wide system of yearly sample surveys
  - collect structural and accountancy data on farms
- Why?
  - to monitor income and business activities of agricultural holdings
  - to evaluate impacts of the Common Agricultural Policy measures





# 1. Introduction to EU FADN

- Who?
  - Only from farms exceeding a minimum economic size
  - EU FADN 2007 sample = 78000 farms, which represent after extrapolation about 5.4 millions farms out of a total of 14 millions in the whole population in EU-27
  - Covers more than 90% of agricultural production, UAA and LU
- When?
  - Since 1965
  - Data from 1989 to 2007
- How does it differ?
  - only source of harmonised micro-economic farm data for the EU
- EU FADN / national FADNs (differences, more details...)



#### • Coverage:

- RD policy scope broader than FADN coverage
- But some RD measures for farmers only or mainly and major part of public expenditure
- Classification variables:
  - Less-favoured areas (LFA)
  - Areas with environmental restrictions





#### • Rural Development payments:

- Only amounts actually received during the accounting year
- Total subsidy (EU + national + private)
- Only some RD payments are individualised:
  - LFA
  - agri-environment
  - afforestation
  - other forestry measures
  - implementing demanding standards
  - use of farm advisory services
- Subsidies on investments mixed with possible national aids
- Complementary National Direct Payments not registered under specific RD codes and may be mixed up with national aids







#### • Possibilities:

- FADN can be used to estimate « GVA change indicators » (CMEF)
- Background knowledge of RD support received by EU farms (LFA/ agrienvironment/ investments subsidies/ total RD)
  - Comparison by type of farming
  - Comparison by region
- To study the characteristics of RD recipients (LFA/ agri-environment/ investments subsidies/ total RD)
- To analyse the link between RD support (LFA/ agri-environment/ investments subsidies/ total RD) and
  - income
  - assets



# RD support / 1rst pillar













# RD support / 1rst pillar by type of farming



#### Structure indicators by category, EU-25










### Income and public support



#### • Limitations:

- Low coverage:
  - Amounts attributable to RD in FADN 2000-2006 : **49%** of the total RD expenditures
    - Difference of scope
    - for the EU-12 Member States CNDPs out
    - some payments 2000-2006 received later
    - the effects of selection and weighting (FADN methodology)
    - inappropriate recording in FADN
  - Coverage varies a lot according to the Member State considered
  - For number of beneficiaries and total expenditures, use other databases (paying agencies)
- Only few measures separated (and AEM not specified..) and small size of the sample for some of them (investments subisidies)
- Origin of the fund not known (EU / national / private)
