## Which answers to climate changes in the rural areas ?

Climate change is today a major and widely recognized determinant of the future of our society and its development prospects.

The impacts of climate change can be already perceived in some fields, the most often in rural areas : natural disasters, drought and flooding, decrease of biodiversity, invasive species, loss of agricultural productivity, and even food shortage,..

But the ongoing climate change affects also territorial cohesion and balanced linkage between towns and countryside. The contributions of rural actors (services, productions,..) and the amenities of the countryside (nature, landscape,..) are basic factors of a long-lasting societal equilibrium : some of these elements are threatened or affected by climate evolution.

How respond to climate change in rural areas ? How can rural actors reduce impacts and tackle causes of climate change ? Which rural contributions to face this global threat ?

By dealing with this issue from a rural approach, the seminar of the European Countryside Movement also renews a key point of the next decades : the recognition of rural areas and their actors as necessary stakeholders for the sustainable vitality of our planet.
