

## National requirements

### ➔ Background Information

Some countries of the Alpine Space Programme set up national requirements as regards the application procedure and ask for additional documents to be submitted within the first or/and the second step of application. These documents are ready for download on the programme website (in the section of the relevant call) and have to be submitted to the relevant ACPs.

### ➔ Guidance

#### Austria

---

##### First step

Information on national requirements will be sent via email to the project partners after submission of the Expression of Interest.

##### Second step

Information on national requirements will be sent via email to the project partners after submission of the Application Form.

#### France

---

##### First step

No national requirements

##### Second step

- 1) Description of the project in French, with a detailed explanation of objectives and results (4 pages).

- 2) Description in French of the detailed activities to be carried out by the French partner, as well as a description of the foreseen pilot sites (4 pages).
- 3) Description of the foreseen budget, detailed by cost categories and work packages (the model of table available by the French ACP). To be noticed: The costs of the First Level Control must be taken into consideration in the total budget!

## Germany

---

### First step

No national requirements

### Second step

- 1) Document **“Verpflichtungserklärung”**
  - Confirmation of National Cofunding of each Project Partner / Lead Partner
  - to be submitted to the German ACP by post (check carefully the deadline fixed by the ACP!)
- 2) Document **“Formblatt”**
  - Checklist for further required information, depending on the type of Partner (private / public)
  - to be submitted to the German ACP by post, together with respective additional documents as required (check carefully the submission deadline fixed by the ACP!)

Further information and explanation can be obtained in the document **“Anschreiben”**, which is also available for download on the programme website.

## Italy

---

### First step

- 1) CV of all Italian Partners (CV format to be filled in and signed by the legal responsible)
- Check carefully the submission deadline fixed by the ACP!

### Second step

- 1) Document **“CV del Partner o Capofila”**:
  - CV of all Italian Partners that joined the project after the 1st step.
  - CV form to be filled in and signed by the legal responsible.

- to be submitted (electronically) to the Italian ACP (spazio\_alpino@regione.lombardia.it).  
Check carefully the submission deadline fixed by the ACP!
- 2) Document **“Autodichiarazione Status Giuridico”**:
  - legal status of the Italian LP and PP.
  - form to be filled in and signed.
  - to be submitted (electronically) to the Italian ACP (spazio\_alpino@regione.lombardia.it).  
Check carefully the submission deadline fixed by the ACP!
- 3) Document **“Autodichiarazione responsabile Legale del LP e dei PP italiani”**:
  - Self declaration by the legal responsible entitled to represent the Partner.
  - form to be filled in and signed.
  - to be submitted (electronically) to the Italian ACP (spazio\_alpino@regione.lombardia.it).  
Check carefully the submission deadline fixed by the ACP!

## Liechtenstein

## Slovenia

---

### First step

- 1) Questionnaire for all Slovene partners (form to be filled in and sent back to the ACP)

Check carefully the submission deadline fixed by the ACP!

### Second step

- 1) Questionnaire - **“Vprašalnik”** to be filled in.
- 2) Questionnaire - **“Dokazila o pravnem statusu prijavitelja”**.
  - Confirmation of legal status of the PP.
- 3) Questionnaire - **“Dokazila o boniteti”**.
  - Proof of credit rating of the PP.
- 4) Questionnaire - **“Dokazila o sofinanciranju nacionalnega deleža iz javnih virov”**.
  - Only for private partners, proof of co-funding of national share for public funds.

Read carefully the instruction note from the ACP: “Posiv” which is made available when the second step is open.

## Switzerland

### First step
