1. APPROVED PROGRAMME: THE RURAL DEVELOPMENT PROGRAMME FOR HUNGARY 2007-2013 C (2007)5121 OF 24 OCTOBER 2007

Note to the reader:

Article 70(4b) of Regulation (EC) No 1698/2005 allows the EAFRD contribution rate to be increased by maximum 10 additional percentage points as a derogation from the ceilings set out in Articles 70(3) and 70(4) of the same Regulation for the expenditure incurred by the Member States during the year 2009.

HU has benefited from the 10 additional percentage points as approved by Decision C(2009)9984 of 14 December 2009 for expenditure of the 4th quarter 2009. These rates will be revised during the 1st quarter 2010 in accordance with article 8a of Regulation 1974/2006.

2. LEGAL BASIS FOR THE MODIFICATION

Modification related to the first implementation of Article 16a of Regulation (EC) No 1698/2005 - Modifications under Article 6, paragraph 1, letter a) of Regulation (EC) N° 1974/2006. The priority chosen is linked to the restructuring of the dairy sector.

3. **REASONS JUSTIFYING THE AMENDMENT / STRATEGY CHOSEN**

The amendment is proposed in the context of the Health Check Reforms and the European Recovery Package.

4 **DESCRIPTION OF THE AMENDMENTS PROPOSED:**

4.1 New priorities / types of operations

In the framework of the European Economic Recovery Package and Health Check reforms Hungary has received an additional allocation of 54 248 000 EUR for its rural development programme.

The analysis in terms of strengths and weaknesses of the performance of agricultural, forestry and food sectors has been updated in the NSP in relation to climate change, water resources, renewable energy, air quality, biodiversity protection of natural heritage, and broadband. Concerning broadband coverage, Hungary has a 87.4% of rural coverage compared with a EU27 average of 76.6%. Hungary is committed to reach 100% broadband coverage target through a large project. The project has already been pre-notified by the Commission. The project is expected to be financed through the ERDF (Economic Development OP 3.1.1-3.1.2, Electronic Administration OP) and ESF (Social Renewal OP).

Following the results of the analysis, the additional funding is proposed to be used for the restructuring of the dairy sector via the animal welfare measure. The measure was not initially programmed in the NHRDP. This operation is not listed in annex II of Regulation (EC) No 1698/2005.

4.2 Description of the amendments proposed to axes and measures

A new measure has been proposed.

Code 215: Animal welfare payments

Intended aims and targets of the measure: to make significant improvements to the welfare of the Hungarian dairy livestock by:

- decreasing stocking density and providing outdoor access where possible;
- improving the housing conditions of milking cows and their calves, improving the feeding conditions;
- preventing diseases, and parasites infections
- to apply higher standards concerning hygienic and feed requirements to the benefit of the animals
- further shift of the milk sector towards high quality milk production and structural rationalization.

The farmer is compensated for the income foregone and the additional costs. Investments cannot be realized through this measure.

Type of operation implemented:

Animal welfare payments may be received by milk producers voluntarily undertaking <u>animal welfare commitments that exceed the baseline animal welfare standards</u>. These payments cover <u>new</u> commitments exceeding mandatory standards determined by Council Regulation 73/2009/EC, Article 5 and Annex II, as well as additional mandatory requirements set in national legislation and in the Programme.

Two types of commitments are foreseen: mandatory and optional ones.

As mandatory commitments, the NHRDP foresees the reducing of stocking density, increasing the frequency of mandatory surveillance, providing an assessment of the risks to the welfare of animals on the farm and an identification of needs for improvements and adjustments in the farm operations to reduce and where possible eliminate the risks and a plan for proper milking technology and preventive interventions.

In addition, the optional commitments foresee for the preventive protection against parasites, the provision of natural conditions (grazing) and extra hay.

Transaction costs related to letting the transaction take place and directly attributable to the implementation cost of the commitment it relates to, such as information gathering and costs linked to the determination of the baseline situation in the farm can be also covered.

Type of beneficiaries: milk producers

Amount of support:

Public expenditure:EUR 62 279 371EAFRD contribution:EUR 54 248 000 out of which

- in the framework of the European Economic Recovery Plan: EUR 48 348 000
- In the framework of the modulation: EUR 5 900 000

Aid intensity: 100%

Rate of EAFRD contribution:

- in convergence regions: 90%
- in non convergence regions: 65%

The maximum grand total sum of support (as a combination of mandatory and optional commitments) is 183 EUR/LU.

Duration of the aid: five years.

It is proposed as a flat-rate, non-refundable, compensatory support, which shall be calculated on the basis of the average annual livestock defined by livestock unit (LU).

Complementarities and demarcation of the measure:

There is no other intervention co-financed by the Community or financed from national funds identical to the proposed support for animal welfare.

5. THE EXPECTED IMPACTS OF THE AMENDMENTS

The financial and economic crisis, as well as the restructuring of the CAP's quota regulation had a harmful impact on the milk sector in HU.

The aim of this modification is to mitigate the problems of the restructuring of the dairy sector. The animal welfare payment is a suitable measure for this goal as significant improvements to the welfare of the Hungarian dairy livestock, notably by decreasing the livestock density, will accompany the ongoing restructuring of the dairy sector. As a side effect higher quality milk will be produced and more preferable environmental effects will be created.

6 ASSESSMENT

General assessment of the modification

The amendment to the rural development programme is of a minor nature.

The possibility of the introduction of the animal welfare measure at a later stage had been foreseen already in the initial NHRDP.

The choice made by HU is coherent with the NSP.

The modifications comply with the relevant requirements of Council Regulation (EC) No 1698/2005 and Commission Regulation (EC) No 1974/2005.
