1. APPROVED PROGRAMME: Second Modification of the Rural Development Programme for **Rhineland-Palatinate** (Germany) for the period 2007-2013 ("EntwicklungsProgramm Agrarwirtschaft, Umweltmaßnahmen und Landentwicklung – PAUL")

2. LEGAL BASIS FOR THE MODIFICATION

Modification related to the first implementation of Article 16a of Regulation (EC) No 1698/2005 and an increase of the total EAFRD contribution for the entire programming period. According to Article 6 (1) a) of Regulation (EC) N° 1974/2006, this revision needs to be approved by Commission decision. Furthermore, the revision is combined with other amendments according to Article 6 (1) c) of Regulation (EC) N° 1974/2006.

The revision has been approved by the Monitoring Committee in its meeting on 18 June 2009.

3. REASONS JUSTIFYING THE AMENDMENT / STRATEGY CHOSEN

The amendments do not have an impact to the objectives set in the National Strategy Plan (NSP) and the regional programme strategy.

Chapters 3 has been completed with a new paragraph 3.2.6 on the strategy considerations (follow up of Health Check and Recovery Package).

Amendment of indicators

Based on the discussion at the annual meeting the quantifications have been clearly defined to avoid imprecise "up to" values (on measure description level in chapter 5 of the below mentioned measures and in the overview given in chapter 5.4 of the programme). In annex 1 of the programme the basis indicators as described in chapter 3.1 of the programme, have been amended and updated (basis indicators: reference year 2006 when possible).

Clarification Public expenditure and EAFRD contribution

Definition has been taken from the NFR as agreed with letter dated 19th May 2009 Ares(2009)104211. Chapter 5.2.15 has been inserted into the programme.

Health-Check, Recovery Package and increase of co-financing rate for Axis 2 non convergence region

In the course of the Health Check, the co-financing rate for axis 2 will be increased per 5% points from 50% to 55% in the non convergence region. Non convergence regions and new challenges will use equal co-financing rates.

Financial changes

Shift of funds between Axis 1, Axis 2, Axis 3 and Axis 4 Leader and within Axis 2. Top-up's are an important factor in national co-financing.

As already started within the 1st modification request (Art.6(1.c) of Reg.(EC) 1974/2006 within limit of 1%), the Leader axis will be again reinforced by shifting of €1.5 Mio funds from axis 3 measure code 322 – "Village renewal and development" into axis 4.

4. DESCRIPTION OF THE AMENDMENTS PROPOSED (*UNLESS SPECIFICALLY STATED, THIS DOCUMENT PRESENTS THE CHANGES OR ADDITIONAL INFORMATION PROVIDED IN THE MODIFICATION REQUEST SUBMITTED BY THE AUTHORITIES OF RP*)

The total additional amount of € 30,219,492 EAFRD contribution (€ 28,362,772 resulting from Health Check and Recovery Package including unused funds according to Article 136 of Council Regulation (EC) No 73/2009 and € 1,856,720 resulting from Commission Decision C(2008)8370 and a correction of the distribution of the existing modulation money to the German *Länder*) will be attributed to the measures shown below.

Chapters 5.2.15, 5.3.6 and 6.3 and one new sub measure 214.15 "Semi-open pasture management" has been added.

4.2 Description of the amendments proposed to axes and measures

Changes relating to the Health Check and Recovery Package and other changes requiring a Commission decision

4.2.1 Code 112 - Support for the setting up of young farmers – other changes

4.2.1.1 Description of the amendment

- a For the measure additional funds in the amount of 2.0 Mio Euro total public expenditure thereof 1.0 Euro EAERD are allocated.
- b The premium will be increased from 10.000 Euro to 15.000 Euro
- c Prosperity threshold is no longer a selection criterion, the prosperity threshold defined in the programme becomes a criterion for exclusion.
- d the wording of Commission Recommendation of 6 May 2003 concerning the definition of micro, small and medium-sized enterprises is replaced by Regulation (EG) Nr 800/2008 declaring certain categories of aid compatible with the common market in application of Articles 87 and 88 of the Treaty (General block exemption Regulation)
- e Clarification , state aid on basis of an approval pursuant to Reg. (EG) 1698/2005 Art. 89

4.2.1.2 Reasons, justifying the modification

- a An increasing demand in the last two years, the support shall facilitate the alternation of generations to the structural change of holdings
- b+c Given the volatile agricultural market and the health check decisions adjustments in the agriculture especially in the dairy sector are essential. The increase in premia shall underline attractiveness and sustainability and give incentives for alternation of generations to the structural change of holdings.
- d+e Clarification needed

4.2.1.3 The expected impact of the amendment

- a The improved support answers to the actual needs in the regions and will support additional holdings. Existing jobs will be safeguarded and additional ones will be provided indirectly.
- b+c In combination with the improved support in measure code 121 in particular in the field of improvement of animal welfare in the dairy sector the course can be set for structural changes and the competitiveness will be improved. The increase is needed to reach the targets.
- d+e The clarifications strengthen the administrative proceedings.

4.2.1.4 Relation between amendment, national strategy and regional strategy

The amendment contributes to the targets set in the national strategy for axis 1 improving the competitiveness and productivity notably safeguarding the succession of agricultural holdings and axis 3 secure the creation of jobs and income and to reach the objective given in the programme.

4.2.1.5 Financial consequences of the amendment

4.2.1.6 Adjustment of quantified monitoring indicators and evaluation

The input- and output indicators as well as table 9 in chapter 5.4 are adjusted accordingly.

4.2.2 Code 121 - Support to individual holdings - Agriculture Investment Support Programme ("AFP")" according to National Framework Regulation (NFR)

4.2.2.1 Description of the amendment

- a For the measure additional funds in the amount of 14,6 Mio Euro total public expenditure are allocated. **Thereof 10.0 Mio Euro total public expenditure (5.0 Mio Euro EAFRD) for the new challenges climatic change and measures to cushion the impact of the restructuring of the dairy sector**
- b The limited amount of 400.000 Euro maximum aid is abolished. Provisions according to the approved national framework are relevant.
- c Prosperity threshold is no longer a selection criterion, the prosperity threshold defined in the programme becomes a criterion for exclusion.
- d The differentiation between eligible costs and basis of calculation is suspended (previous up to 90% of eligible costs)
- e Clarification state aid on basis of an approval pursuant to Reg. (EG) 1698/2005 Art. 89.

4.2.2.2 Reasons, justifying the modification

- a - d The reform of the Common Agricultural Policy and the actual situation on the markets raised the necessity to do the structural change of holdings to secure the competitiveness and substantial investments in rationalisation and amelioration is demanded.
- a **The additional funds shall be attributed to the new challenges climate change (Improve efficiency of nitrogen fertiliser use (e.g. reduced use, equipment, precision agriculture), improvement of manure storage) and measures to cushion the impact of the restructuring of the dairy sector (Investment support related to the dairy sector).**
- c + d The improved support shall attribute to the new challenges climate change and measures to cushion the impact of the restructuring of the dairy sector. Given the volatile agricultural market in particular target oriented investments enhancing competitiveness especially in the dairy sector are essential.
- e Clarification needed.

4.2.2.3 The expected impact of the amendment

- a The improved support answers to the actual needs in the regions.
- a + d Due to the improved support conditions, focus on dairy farms. Higher aid intensity is notably to emend livestock friendly breeding and will contribute at the same time to ameliorate animal welfare. The competitiveness will be improved and existing jobs will be safeguarded and additional ones will be provided indirectly
- e A coherent implementation of measures irrespective financial sources national aid, community contribution shall be granted.

4.2.2.4 Relation between amendment, national strategy and regional strategy

The amendment contributes to the targets set in the national strategy for axis 1 improving the competitiveness and productivity and axis 3 secure the creation of jobs and income and to reach the objective given in the programme

4.2.3 Code 123 - Adding value to agricultural and forestry products– other changes

4.2.3.1 Description of the amendment

For the measure additional funds in the amount of 2.0 Mio Euro total public expenditure thereof 1.0 Euro EAFRD are allocated.

4.2.3.2 Reasons, justifying the modification

The reform of the Common Agricultural Policy and the actual situation on the markets raised the necessity to secure the competitiveness and substantial investments in rationalisation and amelioration is demanded.

4.2.3.3 The expected impact of the amendment

The improved support answers to the actual needs in the regions.

To meet the demand with supplementary projects to improve effectiveness of processing and marketing notably quality requirements to enhance marketing opportunities of agricultural holdings, and to safeguard existing jobs and provided indirectly additional ones.

4.2.3.4 Relation between amendment, national strategy and regional strategy

The amendment contributes to the targets set in the national strategy for axis 1 improving the competitiveness and productivity and improvement of marketing opportunities and structure and income and to reach the objective given in the programme

4.2.3.5 Financial consequences of the amendment

Following financial adjustments

4.2.3.6 Adjustment of quantified monitoring indicators and evaluation

The input- and output indicators as well as table 9 in chapter 5.4 are adjusted accordingly.

4.2.4 Code 125 - Developing infrastructure related to the development and adaptation of agriculture and forestry– other changes

4.2.4.1 Description of the amendment

For the measure additional funds in the amount of 10.0 Mio Euro total public expenditure thereof 5.0 Euro EAFRD are allocated.

4.2.4.2 Reasons, justifying the modification

The actual situation on the markets raised the necessity to secure the competitiveness and to accelerate the reparcelling and land improvement to reduce cost disadvantages. Investments in infrastructure shall contribute to it.

4.2.4.3 The expected impact of the amendment

The improved support answers to the actual needs in the regions. Supplementary projects to safeguard existing jobs and provided indirectly additional ones.

4.2.4.4 Relation between amendment, national strategy and regional strategy

The amendment contributes to the targets set in the national strategy for axis 1 improving the competitiveness and productivity in the agricultural and forestry sector to reach the objective "improvement of the competitiveness" given in the programme.

4.2.4.5 Financial consequences of the amendment

Following financial adjustments

4.2.4.6 Adjustment of quantified monitoring indicators and evaluation

The input- and output indicators as well as table 9 in chapter 5.4 are adjusted accordingly.

4.2.5 Code 126 - Restoring agricultural production potential damaged by natural disasters and introducing appropriate prevention actions

4.2.5.1 Description of the amendment

For the measure additional funds in the amount of 1.7 Mio Euro total public expenditure are allocated thereof 0.85 Mio Euro EAFRD for the new challenge climatic change.

4.2.5.2 Reasons, justifying the modification

The climate change requires additional effort to ensure production safety. The realisation of flood water prevention and management measures shall be intensified.

The additional funds shall be attributed to the new challenges climate change (Prevention mechanisms against adverse effects of climate-related extreme events).

4.2.5.3 The expected impact of the amendment

Already prepared projects shall be accelerated.

Supplementary investments are to safeguard existing jobs and provided indirectly additional ones. **Contribution to the new challenge climate change (Reduction of negative effects from extreme weather events on agri-cultural production potential).**

4.2.5.4 Relation between amendment, national strategy and regional strategy

The amendment contributes to the targets set in the national strategy for axis 1 improving reference to climate change for new efforts on flood protection.

4.2.5.5 Financial consequences of the amendment

4.2.5.6 Adjustment of quantified monitoring indicators and evaluation

The input- and output indicators as well as table 9 in chapter 5.4 are adjusted accordingly.

4.2.6 Code 212 - Payments to farmers in areas with handicaps, other than mountain areas – other changes

4.2.6.1 Description of the amendment

For the measure additional funds in the amount of 4.845 Mio Euro total public expenditure and 6.315 Mio Euro EAFRD are allocated.

The co-financing rate will be increased by 5% points from 50% to 55%. Hence the national public expenditure will decrease by 1.470 Mio Euro.

4.2.6.2 Reasons, justifying the modification

It was expected that the provisions for less favourite areas will change in 2010.

Additional funds are needed for the period 2010 -2013. The amounts paid/ha will remain at the 2009 level.

Seen the economic crisis in the dairy sector on prices and demands increasing funds shall be used for the compensatory payments in disadvantaged areas as measures accompanying restructuring of the dairy sector but is an adjustment independent from the Health-Check and Recovery Package and is not seen to compensate temporary economic difficulties

The increase up to 55% shall lead to a coherent proceeding and treatment of Health-Check activities and others activities.

4.2.6.3 The expected impact of the amendment

The income of dairy farmers in less favourite areas will be safeguarded and the cultivation of agricultural land can be secured.

Indirectly the demand in services in rural areas shall be encouraged to safeguard existing jobs.

4.2.6.4 Relation between amendment, national strategy and regional strategy

The amendment contributes to the targets set in the national strategy for axis 2 to maintain as possible an area-wide, site-compatible, sustainable land use.

4.2.6.5 Financial consequences of the amendment

Following financial adjustments

4.2.7 Code 214 – Agri-environmental payments - Health Check and other changes

4.2.7.1.1 Description of the amendment concerning all sub-measures

a

1. General

- It was said during the monitoring committee, that other modifications and Health-Check and Recovery Package modifications should be presented in a single modification request; therefore the situation for Rhineland Palatinate became more complex.
- The figures in SFC2007 are calculated on basis of the new co-financing rates and do not show the picture over the whole period.

2. General situation after Health-Check and Recovery Package

- Net increase of the EAFRD contribution for **measure 214** by €2.100.000 from € 57.959.000 to €60.059.000

 - Feeding only in exceptional cases in time of need
 - Veterinary care
 - No use of fertilizers
 - No use of pesticides
 - Continuous area minimum 10 ha maximum 50 ha, at beginning of the support minimum of 40% natural succession of areas.
 - No ploughing up of grassland

The support can not be combined with other measure.

Annual premium based on surface area 375 €/ha agricultural land.

4.2.7.2.6.2 Reasons, justifying the modification

The semi natural livestock farming shall result in a semi-open grazing land, a natural dovetail connection of forest and open areas in previous vineyards. In particular species needing warmth and bright and other influences of pasture livestock shall benefit of it. With a ratio of 40% bushes it cannot be seen as classic grassland.

4.2.7.2.6.3 The expected impact of the amendment

Presumably on this grazed area, at first herbaceous plants like creeping buttercup (*ranunculus repens*) and nettles (*urtica dioica*) will grow and partly grassland will emerge. Pasture livestock will create their own grazing land. Ivy (*hedera helix*) damage, caused by pasture livestock, on the vineyard walls shall lead to sun flooded walls to create habitat for colubrid (*Coronella austriaca*), common wall lizard (*podarcis muralis*) and gravel parts will be repopulated by locusts (*oedipoa caerulescens*, *oedipoa germanica*). Other species shall benefit as well like green lizard (*lacerta bilineata*), bunting (*emberiza cia*) and moth (*callimorpha quadripunctaria*).

- Up to 75% of materialised costs, maximum €75 000 per year (increase by 5% points and 25.000 €).
- In areas with more than 60 000 inhabitants, maximum of €90 000 per year (increase 15.000 €).
- Support is limited to two years, in substantiated cases regional management can be extended by three years. The maximum amount is then limited to €50 000 in the fourth year and €40 000 in the fifth year (increase by 10.000 € each).

The improved support answers to the actual needs in the regions.
