1. Approved programme

The Rural Development Programme 2007-2013 for Wales (CCI 2007UK06RPO004) as approved by Commission Decision C(2008)784 of 25 February 2008.

2. Legal basis for the modification

Modification related to the first implementation of Article 16a of Regulation (EC) No 1698/2005; Changes to the total Community contribution for the entire programming period - Revisions under Article 6, paragraph 1, letter a) of Regulation (EC) No 1974/2006.

3. Reasons and any implementation problems justifying the amendment

A. Introduction of additional funding from the increase of the EAFRD ceiling for the UK set in Commission Decision 14/2009.

Commission Decision 2009/14/EC of 17 December 2008 amended the Member State EAFRD allocations. €100,000 of the increase in the UK allocation has been distributed amongst the four regional rural development programmes of the UK. Wales has received an additional €9,000. This amount is not allocated to any specific measures or operations. It is included within the "EAFRD – non-convergence" allocation for 2013 and applied to Axis 2 in the financial tables but is otherwise disregarded in the remainder of this working document as the amount is too small to have any meaningful impact.

B. CAP Health Check – European Economic Recovery Package

Following the approval of the European Economic Recovery Package (EERP), additional resources have been made available to Wales as Community support for rural development in view of the new obligations. It is therefore necessary to revise the Rural Development Program 2007-2013 for Wales (RDP), alongside the UK National Strategy Plan (NSP). This revision of the RDP addresses, at the same time with one single programme modification proposal, the priorities referred to in Article 16a of Regulation (EC) No 1698/2005, as amended following the CAP Health Check (Reg. 74/2009) and the EERP (Reg. 473/2009).

CAP Health Check

The RDP commits the Welsh Assembly Government to review support provided under Axis 2. Following an extensive consultation, a new scheme called Glastir was announced on May 5th and it will be introduced with agreements running from 2012. This scheme will replace Tir Gofal, Tir Cynnal, the Organic Scheme, Tir Mynydd and the Catchment Sensitive Farming Scheme.

The existing schemes will deliver on the new challenges agenda until the Glastir scheme becomes fully operational.

European Economic Recovery Package

Take up of broadband has increased in Wales significantly over recent years and is now on a par with the UK average. Furthermore, recent research by the telecommunications regulator, Ofcom, suggests that broadband take up in rural parts of Wales compare favourably with take up in urban areas.

In practice, however, local issues, such as line length and variable network quality mean that some locations continue to face difficulties accessing a broadband service. Consumers report issues ranging from total lack of service to patchy or intermittent service. Some of these issues are documented in Wales' urban areas; however, the majority of known broadband notspots are distributed throughout Wales' rural areas. These areas also feature a lack of third generation mobile broadband services and diminished second generation mobile coverage. This suggests that additional investment by the market will be required to enable mobile broadband in these areas. There is an opportunity to target investment to extend and upgrade high-speed broadband services in these rural communities.

The above mentioned strategic approach of the Welsh Assembly Government relates very well with the national strategy of the UK as this is described in the NSP. More specifically, the UK authorities mention that:

- concerning Health Check, considering that the size of the UK budget will not increase as part of the Health Check reforms and because the emphasis of the UK programmes is already on delivering environmental benefits, the UK regions will predominantly deliver the new challenges via existing schemes under axis 2.
- concerning the EERP, although broadband availability is high in rural areas of the UK, given the growing importance of broadband, there is a case for addressing availability in the "white-spot" areas and for improving the speed and quality of the broadband connection. With this in mind, the UK government published in June 2009, a report entitled "Digital Britain". This report sets out a commitment to deliver 2mb per second broadband access to everyone in the UK by the end of 2012. In response to the EERP, UK programmes will set a priority for delivering improved access to rural broadband.

The indicative financial allocation of the amounts resulting from the CAP Health Check and the EERP is presented in Table I.

4. Description of the amendments proposed

4.1 New priorities / types of operations

CAP Health Check

In Wales, the primary focus of activities under Axis 2 is on enhancing the environment. These activities will contribute significantly to the aims of the new challenges.

As a consequence, the additional compulsory modulation resulting from the CAP Health Check (41 M \oplus) will be covered by the existing agri-environment schemes and the proposed new land management scheme (Glastir). The options under these schemes contribute towards achieving the biodiversity, climate change and water management targets.

European Economic Recovery Package

The Wales allocation from the EERP $(1,6 \text{ M} \oplus)$ will be used to address the availability and speed of broadband connectivity in rural Wales. The RDP 2007-2013 for Wales may thus contribute towards delivering the recommendations in the recently published report "Digital Britain" which outlines the UK's approach to delivering a fully inclusive broadband service.

Table 5.3.6 of the RDP provides information on the types of operations to be supported to meet the obligations, at programme level, resulting from article 16a(3)(a) and article 69(5a) of Regulation (EC) No 1698/2005. In addition, it presents which of these operations are based on existing or new types of operations, as well as the indicative targets for output indicators, broken down by type of operations.

4.2 Description of the amendments proposed to axes and measures

The Welsh Assembly Government is seeking EC approval to amend the text and financial tables within the RDP, in order to identify the operations and funding targeted at the new challenges.

No new measures are proposed. The possibility to fund broadband activities is reinforced under measure 321.

Measure 321

Scope and Actions

The EERP funding will be used to enhance activity that the Welsh Assembly Government is already undertaking to address the broadband needs of rural Wales. A project proposal to cover the whole of rural Wales will be appraised and approved by the Managing Authority. Local Partnerships will be involved in the selection of actions for their areas.

The European Economic Recovery Package funding will support the creation of and enabling access to broadband infrastructure including ground equipment (e.g. fixed, terrestrial wireless, satellite based or combination of technologies).

The EERP will be delivered across any of the eligible rural wards of Wales. The agreed aid intensity rate will be 50%.

Direct recipients of the aid will be a single, or a consortium of, provider(s) of electronic communications services, in particular licensed telecommunications operators, service providers and system integrators. Indirect recipients will be households and businesses in Wales that cannot currently access broadband via commercial telecommunications companies, as well as third party providers who may gain access to a wholesale service.

Demarcation with ERDF

The European Regional Development Fund will not contribute to activities funded by EAFRD that address internet access issues in rural areas.

More specifically, EAFRD funds provided under the EERP will be used under the State aid scheme N57/2005 for the "Regional Innovative Broadband Support" (RIBS) project. The aim is to intervene in all rural wards of Wales and provide first generation broadband. No funding will be provided for backhaul facilities.

On the other hand, ERDF funding for broadband infrastructure in Wales is covered by the State aid scheme N692/2007 for the "Fibrespeed broadband" project. This project will intervene only in 14 business parks in North Wales providing only backhaul facilities.

State aid

The State aid scheme N57/2005 will be used (duration of the scheme 2005-2011).

5. The expected impacts of the amendment

5.1 Impact on the programme implementation

In Wales, operations and activities contributing to the new challenges (except broadband) are already incorporated into existing schemes. A new scheme, Glastir, that will replace the existing schemes, is expected to be introduced by 2012 and this will further strengthen these activities.

In the case of broadband, this amendment will introduce a new scheme which will accelerate the implementation of infrastructure works in rural areas of Wales.

5.2. Impact on the indicators

The impact of the proposed amendment on the indicators is presented in table 5.3.6 of the RDP.

6. Overall assessment

The amendment is in line with the UK National Strategic Plan as revised and submitted to the Commission on 13 July 2009 and is in conformity with Council Regulation (EC) No 1698/2005 and with Commission Regulation (EC) No 1974/2006. Concerning the funds allocated to broadband activities, issues related to demarcation and state aid were highlighted under point 4.2 above.

7. Financial implications of the modification

This amendment involves a financial amendment. Changes to the financial tables have been made and tables 6.1, 6.2 and 6.3 meeting the Commission requirements as described in Annex II of Commission Regulation No 1974/2006 (as amended by Commission Regulations No 363/2009 and 482/2009) are presented in the following pages.
