Is there still any budget available to allow further commitments for cooperation projects (measure 421)?

Availability of budget	Country
All the allocated budget is estimated to be absorbed	CY, MT, PT
Review of cooperation implementation with extra budget made available for advanced LAGs	SI, SK
Budget is still available	 CZ (approximate amount 5 mill. EUR.) DK (30% of the budget for Measure 421) DE (An increase of the budget on regional level is possible. Possibly of shifting from Measure 421 to 413) FI (20 % of the budget) UK-ENG (yes, but not prioritised) IT (yes, in some regions)
If necessary, by the end of the period budget can be changed	FI
