



Why to evaluate innovation?

Show the accountability of rural development interventions and demonstrate:

- how they have fostered innovation in rural areas and
- how innovations contributed to programme results and impacts, to EU rural policy and EU 2020 Strategy objectives.

Better target the EAFRD support to innovation by:

- selecting the most relevant programme beneficiaries and territories,
- employing most suitable eligible actions and
- ensuring effective and efficient operations in line with the findings of the SWOT and needs assessment.

Enhance common learning among stakeholders on how to best support and implement innovation by learning from past experiences, by understanding conditions for success.



Legal requirements related to evaluation of innovation

MA specify in the Evaluation plan:

topics and activities linked to cross-cutting issues

MA ensure the assessment of RDP results and impacts, provide answers to the evaluation questions related to

- Focus area 1A and 1B (AIR of 2017, 2019, ex post)
- Cross-cutting objective on innovation: "To what extent has the RDP contributed to fostering innovation?" (AIR in 2019, ex post)

Requirements for reporting on evaluation of innovation

Quantification of programme achievements in relation to innovation, in particular through answering CEQ1, CEQ2 and CEQ21 and their respective indicators

Results of the assessment of effectiveness efficiency, impact and achievements of the RDP in relation to the EU 2020 target on innovation and RD cross-cutting objective of innovation

Answers to CEQ1, CEQ2, CEQ21, CEQ23, CEQ30 and programme-specific EQS, conclusions, recommendations in relation to innovation



The common evaluation elements for the evaluation of innovation

Common evaluation questions related to:

- Focus areas CEQs 1 and 3 linked to the objectives of Focus Area 1A and 1B to capture the contributions of interventions in terms of expected outputs and results.
- Other aspects of the RDP CEQ 21 to capture the expected outputs and results achieved by NRNs.
- EU level objectives
 - CEQ 30 is linked to the cross cutting objective on innovation and assesses the contributions of the RDP in fostering innovation
 - CEQ 23 is linked to the EU headline target of investing 3% of the EUs GDP in research and development
