### **TOPICS FOR WORKGROUPS:**

### CLLD and multifunding: how to improve its implementation?

Topics and needs related to CLLD implementation are very diverse. Besides rural LAGs there are also FLAGs and Urban LAGs, which offer new opportunities to rural areas that we need to consider. It is very important to create real synergy between different funds and achieve good coherence. Additionally to Simplified Cost Options (SCO) there is a huge demand to simplify procedures (LAGs and authorities), clear description of methods and exchange the experience between other funds and countries are needed. Capacity building of authorities and LAGs is crucial as well as raising the quality of necessary support services for LAGs.

# Coordination between LEADER actors and authorities: how to develop transparent and holistic coordination on a national level?

Effective and transparent coordination between different authorities and ministries at a national level has been challenging. We need to pay more attention to defining the roles of different LEADER bodies and authorities and enable better understanding about simplifying and harmonizing national rules and regulations. Tremendous issues are to ensure the continuity between program periods and smooth implementation in order to guarantee the sustainable functioning of LAGs.

### Local development strategies: how to assure innovative and flexible implementation?

LDS is the tool for local communities to develop rural life in accordance with the needs and potential of their area and people. Local development strategies focus more and more on the creation of attractive, viable jobs, smart technologies, new involvement methods, regional clusters, IT possibilities. Animation activities of LAGs are very important and to achieve a reasonable proportion of administration and animation.

# Transnational and inter-territorial co-operation in the EU and with third countries: how to simplify and harmonize co-operation?

Keywords under this topic are certainly simplification and harmonization of national regulations as well as drawing up good guidelines. It is important to achieve better understanding of TNC and LAGs animation activities among managing authorities — why do we need TNC, what is the added value of TNC? What are we not able to achieve without TNC? Sustainability and effectiveness of TNC is very important to achieve. Umbrella projects, inter-territorial co-operation, regional clusters and co-operation across sectors will give new opportunities for rural areas.

### 25-year-old LEADER method: how to renew it for the 2020+ period?

LEADER as a very successful method is celebrating its 25<sup>th</sup> anniversary. We have collected a lot of experience and contributed strongly to community led local development. We can't deny that the world is changing around us and we need to consider if we are still corresponding with real needs or if we need to make some changes to be adaptive with the changing living and working environment in rural areas. Social cohesion, migration, regional clusters, rural-urban linkages, green economy, climate change, smart solutions, technology, IT revolution and territorial cohesion are getting more and more important to be considered in community led local development. We need to pay attention to keeping the balance between new technologies and resources' management of communities. There have to be strong linkages between new, smart, dynamic development and the knowledge and skills of people in the local communities.
