Implementation of LEADER in Estonia

LAG-s submitted their strategies for approval in November 2015.

Starting time for sub-measures 19.2 and 19.3 was after strategies were approved in April 2016 .

Sub-measures 19.2-19.4 have the same implementing regulation.



26 LAGs, 99,9% of rural area covered with LEADER



TNC* projects until today

<u>2007 – 2013</u>

28 TNC projects

2014 – 2020

Number of TNC projects is **20+ and counting** (LAGs continue submitting new projects).

Partners from different countries: Finland, Latvia, Slovenia, Portugal, Czech Republic, Spain etc.

TNC = TransNationalCooperation



Topics of the projects 2014-2020:

- Culture
- Sustainable tourism
- Rural entrepreneurship
- Youth entrepreneurship
- Youth inclusion
- Rescue
- Etc.

Support rates and maximum support for co-operation projects

 Preparatory technical support for the cooperation projects 100%

Important to know:

LAGs have cooperation projects included in their strategy budget *(usually separate cooperation measure)*. LAG decides how much of the funds delegate to cooperation projects.

- Implementing the cooperation projects max
 90% (might depend on the LAG)
- Maximum support for the project/applicant may not exceed 200 000 euros (might be less, depending on the LAG).





How and when can LAG apply for TNC project?

LAGs have **specified project ideas in their strategies**.

Cooperation projects have to match strategical priorities

All project ideas (new projects proposed) first have to be **approved by the General Assembly of the LAG**

Paying Agency verifies the eligibility of the applications.

Usually cooperation projects can be submitted at any time (if above criteria is fulfilled). LAG can set limits in their strategy.



Requirements and limits for cooperation project

- At least 2 LAGs must participate (local or international)
 - LEADER/CLLD LAGs in European Union
 - public-private partnerships that implement a local development strategy that aims at development of rural areas (within or outside the EU)
- Cooperation agreement signed by all parties must be submitted with the project application
- Duration of the project max 3 years.
- Last cooperation project must be submitted no later than 31st of December 2020.





Paying Agency (PA) will approve the project **within 60 days after the submission** of the project to the PA.

Approval of a co-operation project does not depend on the fact that all the partners in other countries have approved the project.

If any of the partners should not get the approval then LAG must change the project and partnership agreement.
