## Data item list - purposes

- for all operations, identify data which has to be collected for the CMES in the MS operation database(s)
- Identifies also the main sources: pre-filled by MA, applications, IACS, others...
- ensures data availability for evaluations
- Constitutes a complement to the WD on monitoring and AIR tables where output indicators definitions, list of sub-measures and other monitoring typologies (e.g. agri-environment), rules for monitoring and AIR monitoring template tables are provided
- Includes general information (measures, FA...), output indicators and breakdown (gender/age...)

## Data item list - Structure

3 sections:

- Data which has to be collected for all the measures
- Data relevant for some measures
- Additional data for specific measures

## Data item list – section 1 data for all the measures (1)

General information: measures, sub-measures, FA, programme...

No.	Data item	Example values	Likely info source/comments
1	Measure code	1 to 19	Prefilled by MA on application form
2	Sub-measure code	e.g.: 1.1, 4.1.....	<p>Prefilled by MA on application form, most predominant sub-measure should be used</p> <p>NB This field and the next are not relevant for ALL measures, but are included here so that all measure-identification items are kept together</p>

No.	Data item	Example values	Likely info source/comments
6	Priority/FA to which operation contributes	Priority/FA under which the operation has been programmed: 2A to 6C	Either prefilled (e.g. for specific call for tender) or filled by MA/PA when processing application

## Data item list – section 1 data for all the measures (2)

General information: measures, sub-measures, FA, programme...

9	Is operation implemented under 2007-2013 rules (transitional measures)?	Y/N	Prefilled (e.g. for specific call for tender)
10	If operation implemented under 2007-2013 rules, code of the 2007-2013 measure	Code of 2007-2013 measures	Prefilled (e.g. for specific call for tender)
11	Is operation programmed under a sub-programme(s)?	Code of the sub-programme(s)	Prefilled (e.g. for specific call for tender)

## Data item list – section 2 relevant data for set of measures

## Data item list – section 3 data for specific measures

For monitoring NRN, LEADER, Cooperation, training and advisory services

No.	Indicator	Example value plus Measure	Likely information source
28	Nr training days given	Number 1 (14) 1.1	Application form, plus confirmation/amendment on completion of the operation and/or on an annual basis (for multi-annual operations) by the scheme manager  Only for training (1.1)
