The meeting takes place at a time when the Assembly confirmed its strategic priorities for rural networks and all Rural Development Programmes are approved; the EIP-AGRI network's work plan for 2016 has been defined in line with the indications provided by the Subgroup, including two new Focus Groups which are about to be launched and further three to be launched later on in the year.

- d) To launch a discussion on how focus groups' outcomes can be best used and what kind of follow-up can be considered, based on the experience gained in 2014 and 2015
- e) To discuss how to organise the Subgroup's work throughout the year, based on the experience gained in 2015.
